1. The Center and its Activities

PalThink for strategic Studies Center (the Center) was established and registered in Gaza, Palestine as a non-for-profit organization in 1995 under registration number 563111046. The Center was founded to carry out the following goals: 1) Performing a constructive and facilitative roles in the rationalization of public discussions, thinking and decision processes .

2) Improving quality of life of the Palestinians by promoting innovative development solutions that challenges mainstream thinking on politics, economics and social issues.

2. The Project and Its Financing

Based on the agreement signed between the Swiss Federal Department of Foreign Affairs (FDFA) and the Center (the Agreement) dated February 08, 2011 and effective January 01, 2011 to December 31,2011, the Center was granted financial grant by FDFA to be used for performance the project activities in Gaza Strip, According to the Agreement, FDFA transferred the first installment of CHF 40,000 Equivalent U.S. \$ 42,021 to the Center , the second installment up to a maximum amount of CHF 9,462 equivalent approximately of U.S D \$ 10,100 on receipt and acceptance of an audited financial reports by FDFA .

3. Summary of Significant Accounting Policies

The statement of cash receipts and disbursements has been prepared under the historical cost convention. Significant accounting policies follow.

- **Basis of accounting** The statement of cash receipts and disbursements was prepared on the cash basis of accounting. Receipts are recognized when cash provided by FDFA is received by the Center and disbursements are recognized when the cash payments are made.
- Foreign currency The Center's basic functional currency is the U. S. Dollar. Transactions, which are expressed or denominated in other currencies, were converted to U. S. Dollar using exchange rates in effect at the time of each transaction.
