





Poverty Among Women in Gaza: Between Economic Reality and Lack of Gender Justice

Poverty among women is one of the most complex social phenomena, as it involves physical, political, cultural, and psychological dimensions, and it is subject to changing social, political, and cultural conditions.

Those who are unable to meet their basic needs or enjoy their human rights suffer from poverty. A poor person is a person who cannot satisfy or access their basic needs, including food, housing, shelter, education, and clean water. There are also deprived of creativity, freedom, and dignity.

According to the World Bank, a person is considered poor if their income is less than \$1.90 a day. Other factors affect the standard of living, such as the unequal distribution of wealth and resources, conflicts and wars, environmental and health conditions, and discrimination on the basis of sex, religion, ethnicity, or nationality.

One of the groups most affected by poverty is women, especially in societies where difficult political conditions prevail such as the Gaza Strip. The ongoing crises in the Gaza Strip, which negatively affect the lives of its residents in general, exacerbate the challenges facing women.

This leads to a decline in gender justice indicators for women and makes the possibilities of recovery from this phenomenon in the future very difficult and costly at the societal level. The prolonged economic crises always create scars that are difficult to treat in the near future and weaken women's ability to face challenges and risks that threaten their safety, security, and dignity.

The Role of the Palestinian Media in Political Change

The Development of the Work Civil Society Organizations in the Gaza Strip and the Repercussions of the Division

Civil society organizations play an important role in the Palestinian political and societal life, contributing to their development and improving services, exercising control over the PA and demanding transparency and integrity. difficulties Civil society organizations also face in establishing and registering, due to the existence of conditions from the parties to the division in the West Bank and Gaza. The authorities demand conditions that complicate financial procedures. There is also a state of politicization by political parties and movements that try to control the work of these institutions. Therefore, important reform interventions are required by civil society and Palestinians to free the civil work agenda from these restrictions and obstacles, and to return it to the national path it used to pursue.

The Contribution of Social Media Sites to the Development of Political Practice among Young People in the Gaza Strip

Social media is an important tool for measuring political awareness, solidarity, and awareness, and contributes to the formation of independent political identity and free expression of opinion. Although there are restrictions on freedom of expression in some politically complex areas such as the Gaza Strip, the participation of young people in political affairs through these platforms is considered a form of political practice and the activation of freedom of expression and criticism.

In some cases, social media may be the only or main platform through which young people can participate in public affairs, in addition to contributing to popular monitoring. Social media is particularly important among young people in the Gaza Strip, as it is an interactive and dynamic space that allows them to access political information and analysis, interact with issues and problems that concern them, and express their opinions freely.

These platforms allow them to follow developments and events related to the conflict with Israel, the split between Fatah and Hamas, and the popular movement to resist the occupation and the seizure of their rights. Freedom of Expression in the Gaza Strip: Between Legal Guarantees and Application
